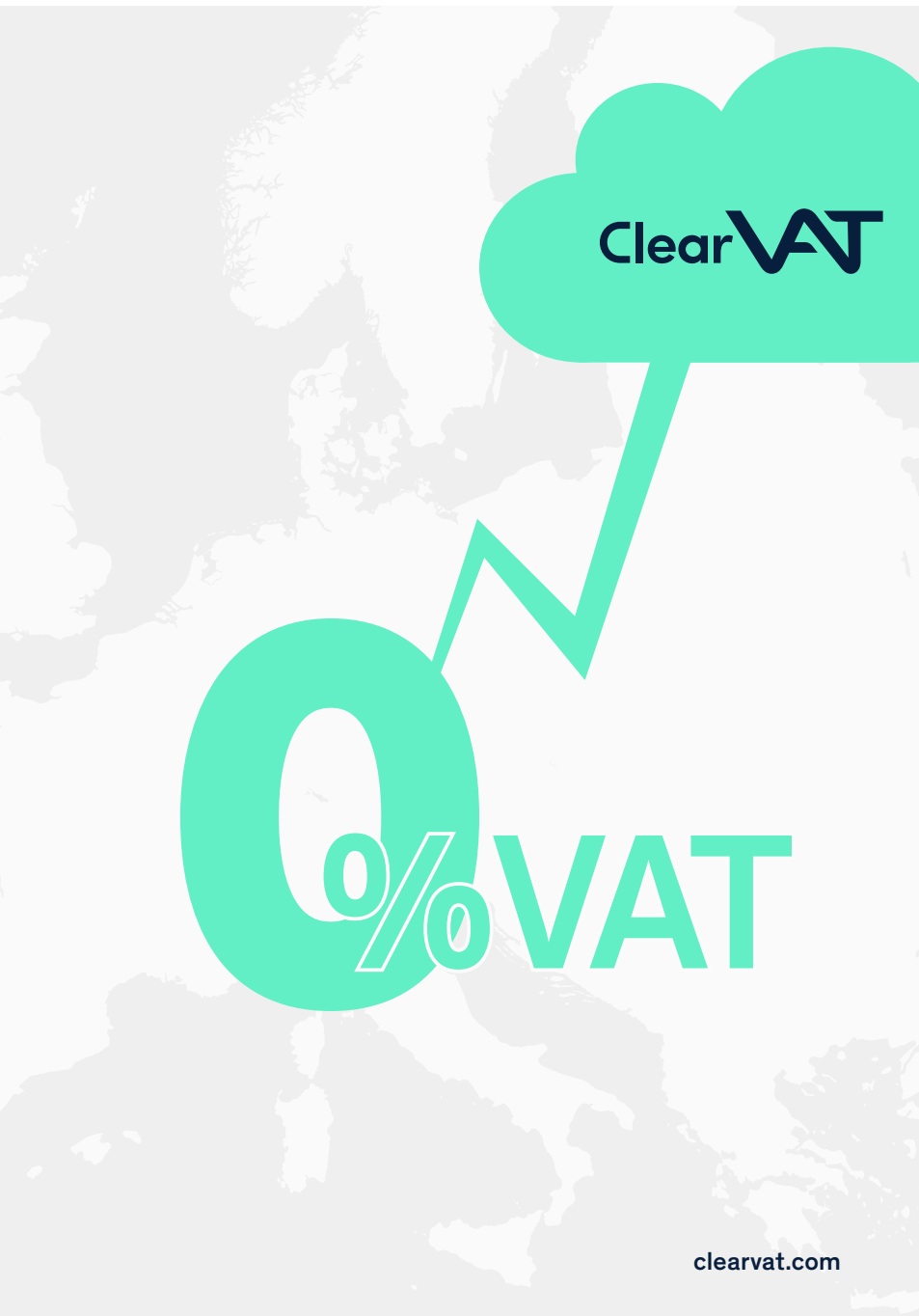

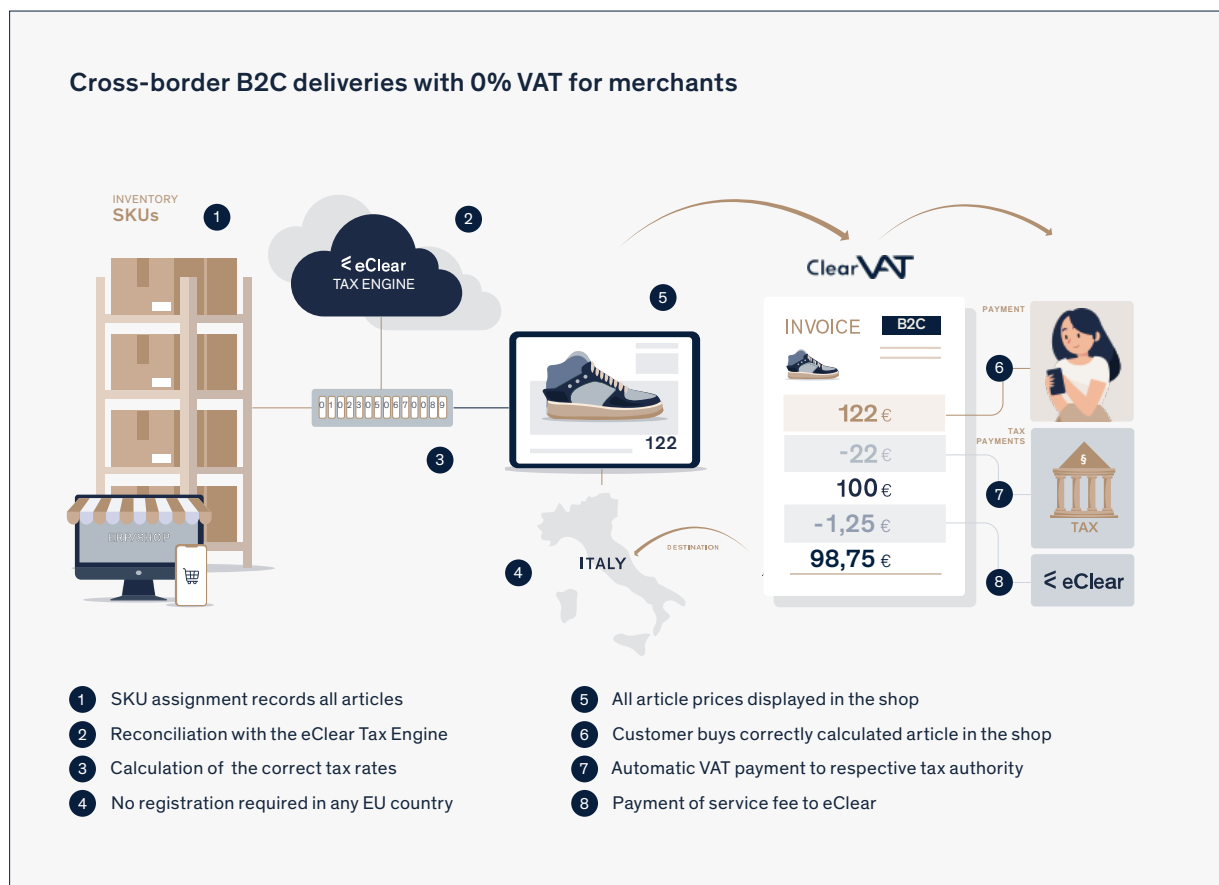


## Cross-border e-commerce with ClearVAT

### VAT 0% – How ClearVAT works

The country of destination principle applies to cross-border B2C sales of goods. Merchants are required to calculate and report VAT according to the regulations applicable in the respective country of the recipient and pay the amount due to the tax authorities there. With ClearVAT, eClear manages all these obligations. For merchants, cross-border B2C sales within the EU are completely VAT-free.
