

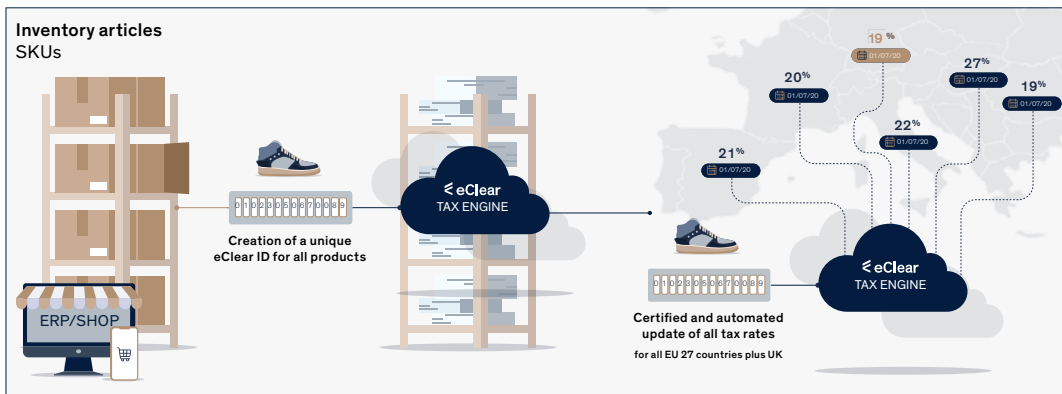

## Functionality

Logistics companies, export specialists and e-commerce enterprises work with a 6-digit customs code. For EU Intrastat declarations, however, you need an 8-digit code. eClear extends the 10-digit European TARIC code by four additional digits. All exemptions, reductions, VAT and customs regulations applicable in the EU are coded here. This level of accuracy is required to provide correct tax rate information for error-free tax declarations.

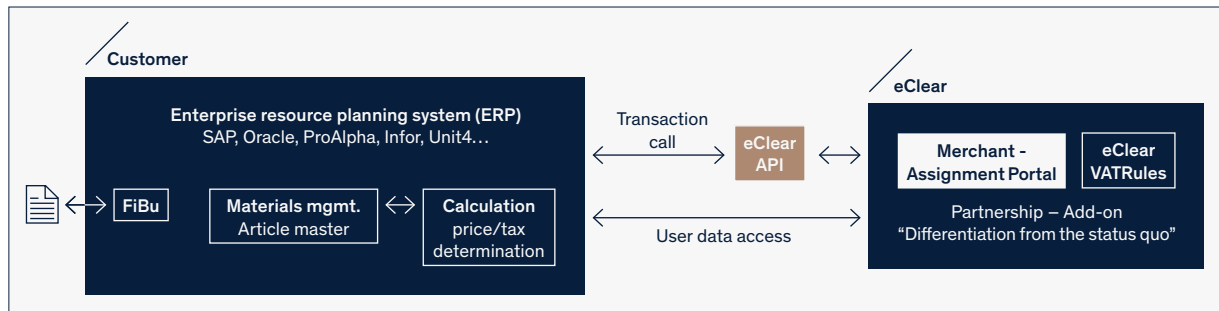
